Gerald Allen is principal of Gerald Allen & Jeffrey Harbinson, Architects, in New York City. He is co-author of *The Place of Houses*, with Donlyn Lyndon and Charles Moore. He has taught at numerous U.S. universities and has published widely in general-interest journals. He received his Masters of Architecture from Yale University.

Dena Belzer recently founded Strategic Economics after serving for eleven years as a principal at Bay Area Economics. She has practiced in the field of urban economics and planning for almost twenty years. She was recognized as Berkeley Small Businesswoman of the Year in 1995. She received a Masters of City and Regional Planning from the University of California, Berkeley.

Charles C. Benton is a Professor of Architecture at the University of California, Berkeley, and a faculty research associate at Lawrence Berkeley National Laboratory. He served as a consultant to Solomon, Inc., during the design and detailing of the Beth Israel Chapel.

Peter Bosselmann is a professor in the departments of city and regional planning, architecture and landscape architecture at the University of California, Berkeley. Author of *Representation of Places: Reality and Realism in City Design*, he directs the Berkeley Environmental Simulation Laboratory and helped establish similar laboratories in New York City and in Tokyo.

Donald Canty, Hon. FAIA, was architecture critic for the *Seattle Post-Intelligence*. He was the editor of *Cascadia Forum*, an interdisciplinary design journal covering the Pacific Northwest and British Columbia. He taught architectural journalism and criticism at the University of Washington.

Clare Cooper Marcus is professor emeritus in the departments of architecture and landscape architecture at the University of California, Berkeley. She is the author of four books, including *People Places: Design Guidelines for Urban Open Space* (with Carolyn Francis) and *House as a Mirror of Self: Exploring the Deeper Meaning of Home*. She won a National Endowment for the Arts Award for Exemplary Design Research in 1983 for her book *Easter Hill Village*. Her consulting firm, People Places, specializes in a user-needs/participation approach to design programming, particularly in the area of public housing modernization and public open space design.

Mark Francis teaches landscape architecture at the University of California, Davis. He is past chair of the Environmental Design Research Association. He is the author of *Community Open Spaces: Greening Neighborhoods through Community Action and Land Conservation*, 1984 (with Lisa Cashdan and Lynn Paxson) and co-editor of *The Meaning of Gardens: Idea, Place and Action*, 1990 (with Randolph T. Hester, Jr.).

Robert A. Gonzalez is an architect, editor of *AULA: Architecture & Urbanism in Las Américas* and Assistant Editor for *Places*. In 1996, he won an ACSA Faculty Design Award and a Boston Society of Architects award for an AIDS Memorial in Key West, Florida (with Paul Kariouk). He is currently a doctoral student at the University of California, Berkeley.

Gary Hack is Professor of City and Regional Planning and Dean of the Graduate School of Fine Arts at the University of Pennsylvania. He is co-author of *Site Planning* (with Kevin Lynch), *Lessons from Local Experiences* (with Robert Eury) and numerous articles and chapters on the subject of the spatial environment of cities. He taught for twenty-five years at that Massachusetts Institute of Technology and was a principal in the firm of Carr, Lynch, Hack, Sandell.

Lawrence Halprin is a landscape architect and environmental planner based in San Francisco. He has been at the forefront of urban design innovation, both as a theoretician and builder, in the U.S. for more than three decades. In addition to the recently completed FDR Memorial, his work includes the Portland Open Space Network, Seattle Freeway Park, Ghirardelli Square in San Francisco, the Haas Promenade in Jerusalem, the Renovation of Chicago's Daniel Burnham Plan and Sea Ranch.

Robert S. Harris, FAIA, is Professor of Architecture and Director of Graduate Programs in Architecture at the University of Southern California. He was one of the first educators to be named Distinguished Professor by the Association of Collegiate Schools of Architecture. He has practiced in Texas, Oregon and California. He chaired the Mayor's Committee for the Los Angeles Downtown Strategic Plan and is active in urban affairs in Los Angeles.

William L. Porter is currently Leventhal Professor of Architecture and Planning at the Massachusetts Institute of Technology, where he served as dean of the School of Architecture and Planning, and a Principal in 4Architecture. He received a Ph.D. in urban studies and planning from M.I.T. and he co-founded *Places*.

Samina Quraeshi is the Henry R. Luce Professor in Family and Community at the University of Miami and an award-winning artist, designer and author who has devoted her life to advocacy for the arts, education and the built environment. She recently served as Director of Design at the National Endowment for the Arts. As principal of the Boston firm, Shepard Quraeshi Associates, she has practiced design and planning for a diverse clientele.

Victor A. Regnier, FAIA, is a Professor of Architecture at the University of Southern California, where he served as Dean of the School of Architecture from 1992-95. Since 1983, he has held a joint appointment at U.S.C. with the Leonard Davis School of Gerontology. He has published widely, including *Assisted Living for the Frail and Aged: Innovations in Design, Management and Financing* (1995), and won a *Progressive Architecture Award* for Architectural Research in 1994 for Assisted Living Housing for the Elderly.

Daniel Solomon is a Professor of Architecture at the University of California, Berkeley, and founder of Daniel Solomon and Associates. He is the author of *Re-Building*, 1992, and co-author of *The Pedestrian Pocket Book*, 1989. His professional work, which focuses on urban design, multifamily housing and private dwellings, has received numerous design awards.

Catharine A. Verhulst is a Principal in 4Architecture. She was the project manager and co-designer for Tanglewood's recent expansion and is continuing as an architectural consultant for Tanglewood. She received a Masters of Architecture from the Massachusetts Institute of Technology.
