**Hilda Blanco** is an associate professor at the Department of Urban Design and Planning at the University of Washington. While on sabbatical last year, she lived in Santa Barbara.

**Earl Blumenauer** is a member of Congress representing Oregon. Before that, he served as a member of the Portland City Council, where he oversaw transportation planning and projects.

**Peter Calthorpe** is principal of Calthorpe Associates in Berkeley, a founder of the Congress of the New Urbanism, and author of *The Next American Metropolis: Ecology, Community and the American Dream*.

**Ellen Dunham-Jones** is a practicing architect, associate professor at the Massachusetts Institute of Technology, and chair of the Education Task Force of the Congress for the New Urbanism. Her practice and research focus on linking contemporary theory and post-industrial exurban development, and the design of infrastructure as public financing.

**Robert S. Harris, FAIA**, a contributing editor to *Places*, is a professor and urban design consultant. He directs the University of Southern California graduate programs in architecture, was dean of the schools of architecture at USC and the University of Oregon, and has been named a distinguished professor by the Association of Collegiate Schools of Architecture. In Los Angeles, he has chaired the Mayor's Design Advisory Panel and the Downtown Strategic Plan Advisory Committee.

**Mark L. Hinshaw, FAIA, AICP**, is director of urban design at LMN Architects in Seattle.
